Subject: Report Regarding the Death of a Foreign National

Sir,

I have been working as a clerk for approximately five years at Siri Guest House, located opposite the Rajamahendravaram Railway Parcel Office. I am married and have two daughters.

On **24-09-2024**, at **2:30 a.m.**, Mr. [REDACTED], a 72-year-old foreign national from Scotland, checked into Siri Guest House. He was allotted **Room No. 8**, which had been booked by Mr. [REDACTED], a resident of Narayana Street, Rajahmundry. Mr. [REDACTED] had previously stayed at our guest house as well.

During his stay, Mr. [REDACTED] would go out for walks in the morning and evening but otherwise remained in his room. Over the past five days, he has been unwell and with the help of [REDACTED], he is undergoing treatment at the hospital. He has been receiving medical treatment for low platelet levels.

On the evening of **02-10-2024**, at around **9:00 p.m.**, Mr. [REDACTED] was last seen stepping out of his room to use the bathroom before going back to his room.

On **03-10-2024**, at **5:00 a.m.**, Ms. [REDACTED], a staff member at Siri Guest House, brought tea to his room. When she pushed the door open and called out to Mr. [REDACTED] she found him lying motionless on the bed and informed me.

I immediately called Mr. [REDACTED], and together we contacted an ambulance. We transported Mr. [REDACTED] to the Rajahmundry Government Hospital, where the attending doctor examined him and declared him **deceased**.

In light of these events, I respectfully request that appropriate action be taken regarding this matter.
